

#### NOTICE:

Inspect item carefully before attempting to install. If there is any damage or obvious defect, do not install. Item may not be returned once it has been installed.


- 1. Carefully remove all parts from the box. Place on a clean, soft surface.
- 2. For best results fully charge battery before use.
- 3. Test the lamp.

**Dimmer switch operation:** Touch dimmer **(A)** to adjust between high, medium, low and off settings (see diagram 1).

#### **CHARGING INSTRUCTIONS:**

- Install plug (D) to adapter (C) as shown in diagram 2.
  NOTE: CE, SAA, UK & CCC plug adapters included.
- 2. Connect USB-C (B) to adapter (C) and fixture, then plug into electrical outlet.

**NOTE:** For convenience, USB-C to USB-A adapter is included.




#### **CARE INSTRUCTIONS:**


