DESCRIPTION

Audrey Tunable White Bath Bar with 1 Inch Rectangle or 4 Inch Square Canopy features an opaque white diffuser lens that provides uniform, tunable white light without hotspots. Can be mounted in horizontal or vertical position. Available in various increments from 12 to 120 inches, a variety of finishes, and Tunable White (2K4K) color temperature. Tunable White can be controlled to operate at either 2000K or 4000K and any kelvin (color) temperature in between. Chrome finish available up to 84 inches. Finished lengths include end caps. Fixture includes 10 LED watts per foot and can be controlled to operate at either 2000K or 4000K, or any color temperature in between. Supplied with a floating canopy: Slim Profile 1 inch rectangle (1RE) which does not require a canopy or a 4 inch square (4SQ) canopy. Canopy may be located anywhere along the fixture length. Fixture includes a 120 volt input, 24VDC Class 2 electronic low voltage LED transformer that fits inside a standard square 4 inch electrical box with round plaster ring and floating split canopy (4SQ), or the Slim Profile Junction Box (1RE) that does not require a canopy. Dimmable with an electronic low voltage dimmer (tested and approved: Lutron Diva DVELV-300P, Lutron Skylark SELV-300P, Lutron Maestro MAELV-600, Lutron Radio Ra 2, or Legrand Adorne ADTP703TU), sold separately. ETL listed. ADA compliant. Suitable for damp locations. Includes a 5 year warranty. Product is built to order.
